From our EXECUTIVE DIRECTOR



"I hold their stories close to my heart." As I look back on fiscal year 2024 at Canopy Child Advocacy Center, I think of the more than 3,000 children who have courageously come to tell their story since we opened our doors in late 2018. I can recall memories of the first youth and families that we served, and I hold their stories close to my heart. We were privileged to amplify their voices then, and we are privileged to amplify the voices of others now.

This amplification has happened in many more ways than just telling their story and receiving the care and support they deserve. We amplified their voices when:

- The full implementation of the Child Protection Team, an intentional partnership with Cuyahoga County to expand to serve severe physical abuse, saw more than 100 children served who previously would not have had access to the Center.
- The 2nd annual One Place One Time Gala attracted a sold-out crowd of 440 guests, raising \$187,000 to serve more children.
- Canopy received the inaugural *Early Childhood Team Innovation Award* from Cuyahoga County Invest in Children, and proclamations from both Cleveland City Council and Cuyahoga County Council recognizing April as Child Abuse Prevention Month.

The amplification of the voices of the most vulnerable in our community will be evidenced throughout this annual report. We hope you will be inspired by the expansion of community support, partnerships, and funding as we work to continually reach even more children and families who need our canopy of care, support, and advocacy.



Our multidisciplinary team conducts case reviews and meets with Cuyahoga County families from the beginning of their engagement with Canopy to the end of their journey towards healing. This ensures that the child has all the support from law enforcement, medical, therapy, child protective services, victim advocacy and prosecution as they have to tell the worst story of their lives.

Canopy by the Numbers *July 1, 2023–June 30, 2024*

Canopy experienced a 20% increase in the number of new children served over the previous fiscal year. Numbers continue to grow and we are reminded that each and every number reflected in the report below is a child with a name, a life and a future. Of the 426 children served, 294 received forensic interviews. Victim Advocacy, which can include providing information and referrals to beneficial resources and supporting victims as they engage with the criminal justice and social service systems, was provided 2,841 times and youth received therapy 640 times.

ALLEGATIONS

Sexual Abuse: 244

Canopy is fully accredited through the National Children's Alliance. In 2023, nearly two-thirds of all cases handled in Child Advocacy Centers involved child sexual abuse.

Problematic Sexualized Behavior: 38

Problematic sexual behavior (PSB) is behavior that is outside of what is considered developmentally appropriate among children ages 17 and under. Youth with PSB develop the behaviors for a variety of reasons, but it has been found that less than 3% of youth with problematic sexual behaviors who receive intervention and treatment reoffend.

Human Trafficking (Sexual): 16

Children may become victims of human traffickers. According to the National Child Traumatic Stress Network, sex trafficking occurs among all socioeconomic classes, races, ethnicities, and gender identities in urban, suburban, rural communities, and on land-based nations and other tribal communities across the U.S. Canopy partners with Northeast Ohio Human Trafficking Task Force, other local law enforcement, and child serving organizations to serve these youth.

Internet Crimes Against Children: 3

Internet Crimes Against Children (ICAC) is a nationwide network of 61 coordinated task forces developed to respond effectively to technology-facilitated child sexual exploitation and internet crimes against children.

Physical Abuse and Neglect: 122

In early 2023, Canopy partnered with Cuyahoga County to create the Child Protection Team and expand services to severe physical abuse. This expansion has allowed us to go from serving one child in 2022, to serving 121 children in fiscal year 2024.


